This includes if you are late or participating in Peer Tutoring. Students are to park in Student Parking only. Current hangtags must be displayed hanging from the rearview mirror and visible outside of the vehicle (not facing inside). Go directly to a parking spot. Do not let people out before parking. Students are expected to leave their vehicles and enter the school building immediately after parking. Students may not go to their vehicles without permission from an administrator during the school day.

- Observe the 10 MPH speed limit on campus.
- Do not drive through the bus-loading zone when buses are present.
- Hangtags are non-transferable. If you lose it or it is stolen, you will be charged a \$10 fee to replace the tag.
- Horseplay and loud music in or around vehicles is prohibited.
- The Gibbs High School Administration has the right to revoke driving privileges for any reason listed above and including, but not limited to, the following: student is not in good academic standing; leaving campus without permission; excessive tardiness to school, unsafe driving on campus and/or class cuts.

PARKING DISCIPLINARY APPROACH:

Failure to adhere to the parking and traffic guidelines may result in school discipline and the possibility of temporary or permanent suspension of parking privileges.

KNOX COUNTY SCHOOL BOARD POLICY (J-200) REGARDING SEARCH AND SEIZURE:

Students have full responsibility to secure their vehicles while they are on school property. A principal or his or her designee may search any vehicle parked or otherwise located on school property if there is reasonable suspicion to believe that the vehicle contains a dangerous weapon or drug or contains evidence of a violation of school rules or regulations which endangers or has endangered the health or safety of any member of the student body. Students will be held responsible for any prohibited objects or substances, such as alcohol, drugs, or weapons that are found in their cars and will be subject to disciplinary action.
